### Course Description

An introduction to theory and research in personality and related individual differences.

### **Assessment Methods**

#### **Mid Term Closed Book Multiple-Choice Exam:**

1. Weight: 35% of final grade
2. Date: February 25 (60 minutes)
3. Format: Multiple-Choice Exam (closed book)

The use of resources, including class notes, the textbook, online resources, and calculators is prohibited during the exams in this course. Students may not communicate with others about course material or the exam either in person or electronically during exams.

NOTE: The Make-up exam format may be different (e.g., could be short- or long-answer questions)

4. Material to be covered: lecture notes covered from January 12 to February 23; *Individual differences & Personality* Chapters 1, 2, 3, 4, and 6; the H factor Chapters 1, 2, 4, and 5.
5. Students have the option to start their exam at a time that best suits their situation within the 24-hour time period.
6. Students will be given an additional 50% time extension (i.e., 30 minutes) to allow for any technological issues that may arise. That is, the 60-minute exam will be set up to allow 90 minutes to be completed, once it is started within the 24 hour period.

#### **Final Term Closed-Book Multiple-Choice Exam:**

1. Weight: 35% of final grade
2. Date: Arranged by registrar (exam duration TBA)
3. Format: Multiple-Choice Exam (closed book)

The use of resources, including class notes, the textbook, online resources, and calculators is prohibited during the exams in this course. Students may not communicate with others about

course material or the exam either in person or electronically during exams.

NOTE: The make-up exam format may be different (e.g., could be short- or long-answer questions)

4. Material to be covered: lecture notes covered from March 2 to April 15; Individual differences & Personality Chapters 7, 9, 10, 11, 12, and 13; the H factor Chapters 3, 6, 7, 8, and 9.
5. Students have the option to start their exam at a time that best suits their situation within the 24-hour time period. Students will be given an additional 50% time extension to allow for any technological issues that may arise.

\*\*Exams in this course are closed book. The use of resources, including class notes, the textbook, online resources, and calculators is prohibited during the exams in this course. Students may not communicate with others about course material or the exam either in person or electronically during exams.

### **Essay**

1. Weight: 30% of final grade
2. Date: March 16 (by midnight)
3. Each student will write an essay describing the personality of a fictional character from a novel with the word limit of 1,500 to 2,000. Detailed instructions of the assignment will be provided via the relevant materials which will be posted on D2L by January 26. You will be evaluated on how well you describe character's personality based on correct understandings of the personality factors following the instructions of the assignment as well as on writing quality and style.
4. Method of submission: D2L dropbox.

Without instructor approval, late assignments will be penalized 10% per day, including weekends.

### **Department of Psychology Criteria for Letter Grades**

Psychology course instructors use the following criteria when assigning letter grades:

A+ grade: *Exceptional Performance*. An A+ grade indicates near perfect performance on multiple choice and short answer exams. For research papers/essays/course projects/presentations, an A+ grade is awarded for exceptional work deserving of special recognition and is therefore not a common grade.

A, A- Range: *Excellent Performance*. Superior understanding of course material. Written work is very strong in terms of critical and original thinking, content, organization, and the expression of ideas, and demonstrates student's thorough knowledge of subject matter.

B Range: *Good Performance*. Above average understanding of course material. Written work shows evidence of critical thinking and attention to organization and editing but could be improved in form and/or content.

C Range: *Satisfactory Performance*. Adequate understanding of course material. Knowledge of basic concepts and terminology is demonstrated. Written work is satisfactory and meets essential requirements but could be improved significantly in form and content. Note: All prerequisites for courses offered by the Faculty of Arts must be met with a minimum grade of C-.

D range: *Marginally meets standards*. Minimal understanding of subject matter. Written work is marginally acceptable and meets basic requirements but requires substantial improvements in form and content. Student has not mastered course material at a level sufficient for advancement into more senior courses in the same or related subjects.

F grade: *Course standards not met*. Inadequate understanding of subject matter. Written work does not meet basic requirements. Student has not demonstrated knowledge of course material at a level sufficient for course credit.

### **Course Credits for Research Participation (Max 2% of final grade)**

Students in most psychology courses are eligible to participate in Departmentally approved research and earn credits toward their final grades. **A maximum of two credits (2%) per course, including this course, may be applied to the student's final grade. Students earn 0.5% (0.5 credits) for each full 30 minutes of participation.** The demand for timeslots may exceed the supply in a given term. Thus, students are not guaranteed that there will be enough studies available to them to meet their credit requirements. Students should seek studies early in the term and should frequently check for open timeslots. The last day to participate in studies and to assign or reassign earned credits to courses is **Thursday, April 15, 2021.**

### **Absence From A Test/Exam**

Makeup tests/exams are **NOT** an option without the approval of the instructor. Students who miss a test/exam have up to 48 hours to contact the instructor to ask for a makeup test/exam. It's the instructor's discretion if they will allow a make-up exam. Students who do not schedule a makeup test/exam with the instructor within this 48-hour period forfeit the right to a makeup test/exam. At the instructor's discretion, a makeup test/exam may differ significantly (in form and/or content) from a regularly scheduled test/exam. **Once approved by the instructor a makeup test/exam must be written within 2 weeks of the missed test/exam on a day/time scheduled by the instructor.
